Membership Form Frequently Asked Questions

Will my membership expire?

Yes, 30th June each year. Memberships are renewed annually from July 1st and last for 12months.

Why do I need to supply my Drivers Licence Number?

We need this information to comply with our licencing requirements from the Department of Racing Gaming and Liquor.

What is an Associated Organisation, and how do I know if I am a current financial member of one?

An Associated Organisation is a club or organisation that has put its financial interest into using the facilities at the LSA. Currently there are 6 Associated Sporting Clubs, if you or your Child are a current financial member, normally by paying a registration / membership fee to the club or organisation you are generally a financial member. If you are unsure contact a committee member of the club or organisation in which you have paid the fees.

I have paid registration fees with my nominated Associated Organisation, is the LSA Membership fee included in this?

No, any registration or membership fees you have paid to your Associated Organisation are for them only. (unless your organisation has informed you that this is what they intend to do)

I am not associated with an Organisation, how do I become a member?

Easy, just fill out the membership form and select any of these options, Social Individual, Social Family or an Ordinary Individual. The price for each option is on the form.

I am with more than one Associated Organisation, which one do I nominate?

Any, just put your preference on the form.

How do I pay for a membership?

If you have received an invoice you can pay this via Bank Transfer, otherwise Cash or EFTPOS payments are accepted at the bar during normal opening hours.

Can I update my details online?

Not yet, but this is something the LSA is currently exploring.

My Child will be turning 18 during the year, what do I need to do?

Just fill out the membership form as you would normally, your child will be covered on your membership until the next financial year that the membership is due. Your child will then be required to fill out their own membership form.

Do I need a membership card?

Yes, going forward you will need to show your card upon entry to the bar, this keeps us in line with our licencing requirements.

How do I get my membership Card?

Pop in and see our bar attendant during normal opening hours to collect your card. If you have not yet paid for the current financial year's membership, the card will not be given to you. All adults on the membership form have been allocated a card. Please allow two weeks after you have paid, for your membership card/s to be ready.

What are the different types of Memberships?

Associated Individual – 1 person only, that is a current financial member with an Associated Organisation

Associated Family – 2 Adults and dependent children UNDER 18 years of age, that is a current financial member with an Associated Organisation

Social Individual – 1 person only, ***not*** with an Associated Organisation

Social Family – 2 Adults and dependent children UNDER 18 years of age, ***not*** with an Associated Organisation

Ordinary Individual – 1 person only, that will be eligible to vote.

Do you check to see if I am with an Associated Organisation?

Yes, the LSA will be working closer with the clubs to make sure you are with the club you have nominated. An invoice will be issued for the difference and your membership will not be valid until the correct membership rate has been paid.
